Councillors Allowances for the municipal year 2021 to 2022

Under the Local Authorities (Members' Allowances) (England) Regulations 2003, Lewes Town Council was given the right to pay a basic allowance and travel and subsistence allowances to its Elected Councillors and/or the Chair of the Council.

Following the District Council review of Members Allowances the Town Council agreed to pay the Basic Allowance set at 15% of the District Council's Basic Allowance and index linked.

The Basic Allowance was £497.55 per annum for the period 1 April 2021 to 31 March 2022. A separate Civic Allowance is paid to the Mayor during their year of office, set at a rate of 30% of the District Council's Basic Allowance. The Civic Allowance was £995.75 per annum for the period 1 April 2021 to 31 March 2022. The council in reaching its decision has had regard to the recommendations of the District Parish Remuneration Panel.

Travel and subsistence allowances incurred in connection with the performance of duties are also payable in accordance with the District Council's Members Allowance Scheme.

This notice is published in accordance with s31 (3) of the above regulations. The council will keep records of the allowances paid and this will be available for inspection given reasonable notice. Copies of this record can be provided on request.
